APPROVAL FOR REGISTRATION

I have great pleasure in informing you that Council at its 174th Sitting of Thursday 9th June, 2022, approved your application for registration.

2. In accordance with the provisions of Engineers (Registration, Etc) Act CAP E11 of 2004 (formerly Decree No. 55 of 1970 and 27/92), your name will be entered in the Council's Register and a Certificate to this effect issued to you as soon as the following conditions are fulfilled: -

(a) Payment of a sum of:

1. Engineers	N63, 000. 00 (Sixty-Three Thousand Naira Only)
2. Engineering Technologists	N35, 000.00 (Thirty-Five Thousand Naira Only)
3. Engineering Technicians	N22, 000.00 (Twenty-Two Thousand Naira Only)
4 Engineering Craftsmen	N13, 000.00 (Thirteen Thousand Naira Only)

(b) 1. Sole Ownership Firm	N100,000 (One Hundred Thousand Naira Only)
2. Partnership Firm	N150,000 (One Hundred and Fifty Thousand Naira Only)
3. Limited Liability Firm	N250,000 (Two Hundred and Fifty Thousand Naira Only)
4. Corporate Ownership	N500,000 (Five Hundred Thousand Naira Only)

(c) Expatriates (Provisional Registration)

1. \$5,000 (Five Thousand Dollars Only)
to cover the cost of registration and issuance of Certificate, etc.

3. Please, note that your name **cannot** be entered into the Register and you cannot practise as an Engineering Personnel or Consulting Firm under the above - mentioned Act unless you fulfil the above conditions within 90 days of the date of this letter. If not, you would need to start the process of registration all over again.

4. Please log into your portal to pay for full registration fee. On successful payment, you will download both Declaration & Acceptance forms (Engineering Personnel & Expatriates only) from your portal, which must be filled & signed by Hand and NOT e-signature then upload and submit. The Two Forms will be vetted by the Admin Officers, after being certified okay, you will be able to download & print your Notification letter with COREN number sent to you on your portal.

5. Expatriates are also required to submit their Immigration documents (Work/Resident Permit) along with the Acceptance & Declaration Forms.

6. Please all payments should be on COREN website www.coren.gov.ng via Applicant's portal.
